We need your stuff! Please help us by cleaning out your basements, attics and garages and donating your excess

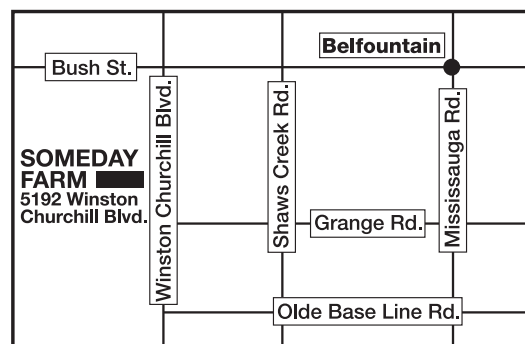

“Rocking Rockfort”: The OMB Update

The Ontario Municipal Board (OMB) hearing for the proposed Rockfort quarry is unfolding in a fair and balanced process. It has been an interesting ordeal – despite the presentation of the most tedious technical details during some days.

We are about six months into the hearing, which began in September, running Monday to Thursday each week. A six-week break is scheduled in March and April and the hearing is expected to conclude by the end of May. Daily postings on the hearing are available at coalitioncaledon.com.

If you’re wondering how this works, the hearing is a quasi-court of law, in procedure. James Dick Construction Ltd (JDCL) entered all his evidence before Christmas pertaining to water, geology, environment, traffic, dust, noise, etc. Currently, the Town of Caledon and the Region of Peel are jointly presenting their opposing evidence followed by Credit Valley Conservation. Then the Coalition will give evidence in April. Final summations will occur in May.

Some interesting highlights have been presented along the way:

- JDCL has brought four lawyers to the table and fifteen experts claiming that the quarry will have no unacceptable impacts!
- Over 200 different exhibits have been tabled and we still have about 8 weeks of the hearing to go.
- The JDCL demonstration test of their grout curtain undertaken in 1999 had many difficulties. The “on the ground” conditions were so challenging it took them 77 working days to grout a small area. During the test, one thin borehole alone took 4.5 tons (yes tons) of cement grout slurry. This raises serious questions about the practicality of the application. The costs are mind-boggling and that’s just if everything goes right.
- It is predicted by JDCL’s water modeling that wetlands to the Northwest, Northeast and East will be impacted by the quarry.

The Coalition is pleased to report that in the last six months two other aggregate cases before the OMB have been turned down due to planning issues. A pit in Puslinch and a quarry near Havelock in Eastern Ontario have been denied. This goes to our point that each proposed site needs to be judged on its own merit. The Coalition, Town of Caledon, the Region of Peel, Credit Valley Conservation and the Niagara Escarpment maintain that Rockfort has too many risks and uncertainties for it to go forward. **We are putting forth your case with vigour so stay tuned!**
